### **Commissioner seeks experts to boost volunteer schemes**

Volunteers who help Dyfed-Powys Police and Crime Commissioner Christopher Salmon are to be given a new support structure.

Mr Salmon plans to engage a partner organisation to help promote, manage, advise and motivate members of his successful volunteer schemes.

He said 'Volunteers are important to my work and I'd like experts in that field to help my office manage their efforts and development.

*'My emphasis on selecting a Volunteer Support Partner will be on the support and encouragement to volunteering they can provide.'*

Bids for the Commissioner's contract close on 23<sup>rd</sup> May.

Mr Salmon runs a number of volunteering schemes across Carmarthenshire, Ceredigion, Pembrokeshire and Powys.

They are a custody visitor scheme which checks on the wellbeing of police cell detainees, an animal welfare scheme which checks on police dogs and handlers, an advisory group which acts as a critical friend to the PCC and Chief Constable, and a panel which checks on police complaints handling.

The Volunteer Support Partnership will support the existing 60 volunteers, encourage volunteering and help in administration.

Mr Salmon said 'Our partner will work with my office to offer our volunteers accessible, friendly and encouraging support

*'They will enhance opportunities and motivate volunteers to acquire skills and experience, and will help with regular meetings and administrative duties.'*

### **BIG Lottery Fund consultation**

The BIG Lottery Fund consultation on its funding strategy and priorities for 2015-2021 is currently underway.

The main vehicle for soliciting responses is an interactive website – [www.yourvoiceourvision.org.uk](http://www.yourvoiceourvision.org.uk) – inviting organisations to post thoughts, ideas, challenges and opportunities to influence this process and two consultation events this month focussing on investment areas including rural poverty, tackling disadvantage, as well as financial literacy, resilience and inclusion.

Communication and collaboration between the Third Sector in Wales and Welsh Government is vital and the mechanisms by which this takes place are set out in the Third Sector Scheme.

The Third Sector Partnership Council (TSPC) is a key element of this engagement and collaboration. The Council is chaired by the Minister for Communities and Tackling Poverty (Jeff Cuthbert AM) and made up of network leads covering 25 areas of third sector activity.

Chwarae Teg is the lead for the employment network and we are working to ensure that we represent the views of as many third sector organisations and groups with an interest in employment as possible.

Employment is a key issue for Wales affecting all third sector groups to varying degrees. It is important that we are drawing on as much experience and knowledge as possible when we are communicating with WG and the TSPC on employment issues, which is why we want to invite any third sector organisations with an interest in employment to join the network.

By doing so you will be able to feed into consultation responses and TSPC meetings and be kept up to date with all of the work we are doing on behalf of the network.

Over the coming months we will be compiling the network's manifesto, which will outline the key priorities for us for the next 12 months. We will be engaging with network members via email and look to hold a face-to-face meeting in a location that best suits those that wish to attend.

### **Millennium Stadium Charitable Trust**

Grants of up to £7,500 are available for not-for-profit organisations with a remit to cover a region or local authority-wide area of Wales, such as Powys or North East Wales.

Funding is available for projects in the following subject areas:

- Sport - The Trust is keen to support volunteer-based projects, particularly from ethnic minorities and people with disabilities. In addition, the Trust recognises the difference that coaching can make to the development of a sport and is keen to fund equipment and coaching costs if the need has been clearly identified.
- The Arts - The Trust aims to give more people the opportunity to enjoy the diversity of performing and visual arts in Wales. The Trust particularly favours proposals which expand and improve arts provision in parts of the country less well served than others and will give priority to organisations which strive to work together to share experiences, practices and ideas.
- The Environment - The Trust encourages applications relating to recycling, developing green spaces, the development and promotion of green practices and the promotion of public transport schemes. Projects that improve the quality of Wales' environment, protect and create a vibrant countryside, and develop and promote sustainable land use planning will be a priority for support. The Trust aims to fund programmes that protect and enhance Wales' natural heritage and promote its sustainable use and enjoyment in a way which contributes to local economic prosperity and social inclusion.
- The Community - The Trust will give priority to organisations that are looking to tackle social, personal, economic or cultural barriers within their own communities. In particular, projects that lead to greater independence and give people more control over their lives will be given priority. The Trust welcomes applications that give people a voice to express their needs and hopes. The Trust is keen to help disabled people to challenge barriers and to be active and visible in their local communities.

### **BBC Performing Arts Fund Fellowships**

Fellowships are available to enable not-for-profit organisations in the UK to support individuals through the early stages of their performing arts career.

Grants of £10,000 are available to host a Fellow through the early stages of their performing arts careers. All Fellowships should offer an opportunity for a talented and motivated emerging performing arts creative to work under the guidance of experienced mentors to develop their skills, experiment, create and showcase their work, and experience the reality of working in a professional performing arts environment.

Applications can be made by performing arts companies, organisations, venues, festivals, agencies and charities from across the UK to host a Fellow who should be selected by the organisation.

Fellowships can be offered to a range of creatives including directors, producers, performers, writers, choreographers, musicians, dance artists, conductors, composers, songwriters, puppeteers, circus performers and theatre makers. Fellows should be ambitious, willing to take on a challenge and looking for ways to increase their profile and take the next step in their careers.

The deadline for applications is 18 August 2014 (5pm).

### **Grants Available to UK Groups for Money/Debt Advice Projects**

Grants of up to £5,000 are available for self help groups and innovative projects that will help educate people about money/debt/ consumer issues. Projects must assist people to improve their quality of life through knowledge and understanding of how to manage and take control of their own financial situation. Projects must also provide outcomes that will benefit their wider communities.

Not-for-profit constituted groups/organisations within the UK that have an annual income of less than £500,000 and whose unrestricted reserves are less than six months of their running costs are eligible to apply.

Applications are being accepted until **31 May 2014** - however, only the first 40 complete applications that meet the criteria will be considered by the Panel.

## Live UnLtd

Live UnLtd provides young people aged 11-21 with the opportunity to create positive change in their communities. This is achieved by offering awards of up to £5,000 to allow individuals to develop their enterprising idea and offering non-financial support from a Live UnLtd team member. Non-financial support can include budgeting advice, networking opportunities and working with volunteers.

For 16-21 year olds, the average award size is £1,500 – with a maximum award size of £5,000. Applications above the average award size are rare and very competitive so please encourage applicants to think carefully about what they really need when applying for an award. If youngsters are aged 11-15, they can apply for awards of up to £500 in addition to support from a Live UnLtd team member. All applicants under 18 years of age will need parental consent to undertake their project and a designated advisor to support them with the development and running of their project should their application be successful.

Key things to remember with regards to the Live UnLtd programme:

- Ideas have to be youth led; Applicants have to be individuals or small informal groups not youth clubs, schools etc – although young people supported by a teacher or youth worker may apply; Enterprises or projects must address a social problem in their community and applicants should be able to say how they will do this.

## £3 million available for community sport in Wales

To mark the 2014 Commonwealth Games in Glasgow, Sport Wales' Calls for Action programme is making available £3 million of investment into community sport across Wales to tackle known gaps in participation amongst women and girls, the BME community, disabled people and those living in poorer parts of the country.

£1.5 million of National Lottery funding will be invested into addressing the barriers currently preventing young women and girls from participating in sport, while a further £1.5 million will look to tackle inequalities around areas of poverty, disability and BME communities. The overarching aim of the scheme is to deliver 'Positive Action' to address known areas of inequality.

The minimum grant is £25,000 and there is no maximum award level. The maximum length of funding period is three years. Applications will be considered from any organisation that can deliver a project that will have a positive impact on the scheme's target groups. Schools cannot be a lead organisation, but can be a partner in a project.

Projects must impact on the following target groups/areas:



- Girls and Young Women
  - Teenage Girls
  - Young Women (20-44 years)
- Young people living in poverty
  - Communities First Areas
  - Communities with schools in Free School Meal Quartile 3&4 (SSS Data 2013)
- Disability
  - Inclusion
- People from a BME Background
  - Cardiff; Vale of Glamorgan; Newport; and Swansea

It awards around 300 grants totalling roughly £2 million each year. The Foundation awards Fast Track Grants of £5,000 and under, Small Grants up to £10,000 and Large Grants up to £30,000.

The [Peter Cruddas Foundation](#) aims to benefit disadvantaged and disengaged young people in the UK by ensuring their funding reaches those most in need. Those they cannot help financially, they hope to help in other ways through mentoring, business planning and networking. The deadline date for 2014 is 1 September.

[Awards for All](#), the small grants scheme from Big Lottery Fund, gives groups a quick and easy way to get small Lottery grants of between £300 and £10,000. The programme aims to help improve local communities and the lives of people most in need.

The [Heritage Lottery Fund's Young Roots](#) grants programme aims to provide young people aged between 11 and 25 years-old with active roles in planning and delivering their own heritage projects. The programme, with an annual budget of £4million, now awards grants of between £10,000 and £50,000. Young Roots is a rolling programme, meaning you can apply anytime.

[sported](#) offers free services to organisations delivering sports projects which use sport to have a positive community or social impact. Applicants must be engaging with young people aged 11-25. Over the past 3 years sported has distributed in excess of £300,000 through its grants programmes.

The [Ernest Hecht Charitable Foundation](#) awards grants that benefit the disadvantaged, with priority categories including: the vulnerable, the young, people who are mentally and physically disabled, and the promotion of the arts, sport and education. The Foundation distributes in the region of £200,000 each year.

### **The Allen Lane Foundation**

The Foundation provides grants for voluntary not-for-profit organisations in the UK.

Overall, the Foundation wishes to fund work which will make a lasting difference to people's lives rather than simply alleviating the symptoms or current problems, as well as projects that are aimed at reducing isolation, stigma and discrimination and that encourage or enable unpopular groups to share in the life of the whole community.

Grants may be used for start-up, core or project costs and generally range from £500 to £15,000. The Foundation makes grants to organisations whose work the Trustees believe to be unpopular such as:

- those experiencing mental health problems, violence or abuse;

The deadline for applications is 21 May 2014. The [Social Ventures - Catalyst Award](#) offers a prize of £5,000 to social enterprises looking to grow their business. The deadline for applications is 16 June 2014.



[Big Issue Invest](#) has opened a second round of its Corporate Social Venturing Challenge, which provides investment for innovative early stage social businesses. The programme uses corporate partners to invest in, support and nurture a new generation of high potential social businesses to grow and deliver sustainable social and financial returns. The CSV Challenge is seeking up to 20 teams for an intensive mentoring programme. At the end, 10 finalists will be chosen to receive an investment of up to £50,000 each, as well as on-going support. The deadline for applications is Monday 19 May 2014.

The programme is offering accredited training as a gift in kind (up to £5,852) to charities across the UK. There are 200 places available.

### **Qualifications and equipment for young people**

The [Lawrence Atwell Charity](#) aims to assist young people who come from a low-income background to become qualified or equipped to work in their chosen career. It provides grants (up to £1500) or loans for young people aged between 16 and 26 towards the cost of vocational training or equipment that is essential for work.



## Instrument and Equipment Awards

## Digital enterprise

HRH The Duke of York and Nominet Trust have created the [Inspiring Digital Enterprise Award. iDEA](#), an award scheme for 16-25 year olds with a flair for all things digital and an entrepreneurial spirit. Over the next five years, the scheme wants to support more than one million young people to pursue their own ideas, develop their digital skills and get to grips with the reality of business. In 2014 iDEA will support 1,000 young entrepreneurs during the pilot stage of the project and will invest over £150,000 in seed funding, with 20 of the best ideas set to receive a grant, mentor support and a business placement.

## Community projects

From 1 April 2014 [The Tudor Trust](#) has made some changes to their funding guidelines. The main difference is a change to the questions asked for the application. The Tudor Trust makes grants, and provides other types of support, to voluntary and community groups working in any part of the UK. It particularly wants to help smaller, community-led organisations which work directly with people who are at the margins of society.

## Disadvantage

The [Lloyds Bank Foundation](#) has launched new grant programmes. *Invest*, *Enable* and *Enhance* –will offer short and long term grants. Support will be adapted to the needs of small and medium sized charities (income between £25,000 and £1 million) that are committed to delivering work which breaks or prevents cycles of disadvantage. The *Enable Programme* will provide smaller short term grants (up to a total £15,000 over two years). The *Invest Programme* will provide longer term core or delivery funding (to £25,000 per year for two or three years) for organisations delivering clear outcomes.



### **European funding**

The European Commission has published a [Call for Proposals under the Erasmus Plus programme](#) with the aim of supporting the introduction or modernisation of apprenticeships within initial vocational education and training (VET) systems. Grants will be for between €100,000 and €300,000 for up to 75% of eligible costs (a total of €4 million is available for this Call). The deadline for applications is 26 June.

[Europe for Citizens Action Grants](#) aim to strengthen remembrance and enhance capacity for civic participation at the European Union level. The programme contributes by developing citizens' organisations' capacity to engage citizens in the democratic life of the EU. A budget of €229 million has been proposed for 2014-2020. Match funding of between 30% and 50% is required. The next deadline for applications is 1 September 2014.

### **Supporting young people**

The [Shackleton Foundation](#) provide up to £10,000 of seed funding and support to enable aspiring leaders and social entrepreneurs to establish their own ventures to help young people in challenging circumstances. Applications should explain what the leader's vision is, and how this vision meets a clear need and benefits disadvantaged and socially marginalised young people.

[Wessex Youth Trust](#) is interested in supporting projects which provide opportunities to help, support and advance children and young people. Preference is given to pump-priming projects for development and more extensive fundraising initiatives. No minimum or maximum level of grant is specified. There are two annual deadline: 1 November.

The [Equitable Charitable Trust](#) is an education charity that gives grants towards projects for children and young people under the age of 25 who are from disadvantaged backgrounds or disabled. The size of grants ranges from £3,000 to £30,000. Applications can be submitted at any time and are considered monthly by the Trustees.

### **Online training**

[Inspire Motivate & Engage \(IME\)](#) an ethical global learning provider, has launched a Corporate Social Responsibility (CSR) initiative providing funding for third sector training courses to employees who would not be able to access such programmes without financial support. The programme is offering accredited training as a gift in kind (up to £5,852) to charities across the UK. There are 200 places available.

### **Lending**

[Charity Bank](#) has announced a major investment of £14.5million from Big Society Capital. The investment enables Charity Bank to increase the amount it lends to charities and other social sector organisation.



### Various causes

The [Freemasons' Grand Charity](#), which has donated over £57 million since 1981, supports projects which deliver important services, complement the work of other charities or tackle issues that are less popular with other funders. Support for Vulnerable People and Youth Opportunities are two of the main areas of focus.

The [Ernest Hecht Charitable Foundation](#) awards grants that benefit the disadvantaged, with priority categories including: the vulnerable, the young, people who are mentally and physically disabled, and the promotion of the arts, sport and education. The Foundation distributes in the region of £200k each year.

The [Coalfields Regeneration Trust](#) is promoting two schemes. Its Community Grant Programme provides from £500 to £10,000 (previously £5,000) to organisations, community groups and social enterprises that can make a positive difference in our communities. . The Enterprising Communities Programme aims to develop capacity and/or community assets in coalfield organisations to enable them to become more enterprising, sustainable, and investment ready.

The [Calouste Gulbenkian Foundation](#) has a small open fund for projects and which are a good fit with their new strategic priorities for 2014-2019: participatory/socially-engaged performing arts; the marine environment; and transitions in later life. Grants average between £10,000 and £30,000.

The [People's Postcode Trust Small Grants Programme](#) is open to applications from organisations in the South of England (excluding Greater London), Scotland and Wales. Grants ranging from £500 to £20,000 (up to £5,000 in Wales) are available for projects that provide assistance in: prevention of poverty; reduction of distress and suffering; advancement of health; citizenship or community development; human rights conflict resolution or reconciliation; participation in sport. The deadline for applications is 23 May.

### The Steel Charitable Trust

The Steel Charitable Trust is a grant-making trust supporting general charitable purposes. Grants are made primarily to registered charities in the UK within the following funding areas:

- Arts and culture
- Environment
- Health
- Education
- Disadvantaged

The total level of grants is expected to be £1,000,000 per annum of which approximately 30% will be made to organisations in the Luton and Bedfordshire area. Grants are generally made as single payments between £1,000 and £25,000.



There is no deadline for applications and all will be acknowledged. The Trustees generally meet in August and November.
